## MULTICURRENCY MEDIUM TERM NOTE PROGRAMME

Ascendas Funds Management (S) Limited (the "Manager"), the manager of Ascendas Real Estate Investment Trust ("A-REIT") wishes to announce that HSBC Institutional Trust Services (Singapore) Limited (in its capacity as trustee of A-REIT) (the "Issuer"), has issued S\$40 million 4.75 Per Cent. Series 001 Notes due 2011 (the "Notes") (to be consolidated and form a single series with the existing S\$110,000,000 4.75 Per Cent. Series 001 Notes Due 2011 issued on 30 April 2009). The Notes are issued under the S\$1,000,000,000 Multicurrency Medium Term Note Programme (the "Programme") established by the Issuer on 20 March 2009. Oversea-Chinese Banking Corporation Limited has been appointed as dealer of the Notes.

Like the existing \$\$110,000,000 4.75 Per Cent. Series 001 Notes Due 2011 issued on 30 April 2009, the Notes have been assigned a rating of "Baa2" by Moody's Investor Service and will mature on 29 April 2011 and bear a fixed interest rate of 4.75% per annum payable semi-annually in arrears.

The net proceeds arising from the issue of the Notes (after deducting issue expenses) will be used for the general working capital purposes of A-REIT.

Approval in-principle has been granted by the Singapore Exchange Securities Trading Limited ("SGX-ST") for the listing and quotation of the Notes on the SGX-ST. Admission to the Official List of the SGX-ST and quotation of the Notes on the SGX-ST is not to be taken as an indication of the merits of the Issuer, A-REIT, the Manager, the Programme or the Notes.
