# Ascendas Reit divests No. 84 Genting Lane

22 December 2017, Singapore – Ascendas Funds Management (S) Limited (the "Manager"), the manager of Ascendas Real Estate Investment Trust ("Ascendas Reit") is pleased to announce that HSBC Institutional Trust Services (Singapore) Limited (in its capacity as trustee of Ascendas Reit) (the "Trustee") has entered into a sale and purchase agreement with Axxel Marketing Pte Ltd (the "Purchaser") on 22 December 2017 for the sale of No. 84 Genting Lane (the "Property") for S\$16.68 million ("Proposed Divestment").

The Proposed Divestment is in line with the Manager's proactive asset management strategy to redeploy capital and optimise returns for Unitholders. The proposed sale price of S\$16.68 million is 66.8% higher than the original purchase price of S\$10.0 million. The market valuation of the Property was S\$15.8 million<sup>1</sup> as at 31 March 2017.

The Proposed Divestment is not expected to have any material effect on Ascendas Reit's net asset value and distribution per Unit for the Financial year ending 31 March 2018.

Assuming the Proposed Divestment was completed on 1 April 2016, the pro forma impact on Ascendas Reit's net property income and distribution per Unit for the financial year ended 31 March 2017 would have been a reduction of approximately S\$1.2 million and 0.02 cents respectively.

Net proceeds after divestment costs are expected to be S\$15.3 million. The proceeds may be recycled to fund committed investments, used to repay existing indebtedness, extend loans to subsidiaries, and/or fund general corporate and working capital needs. If the net proceeds were used to repay Ascendas Reit's debts as at 30 September 2017, its aggregate leverage will be reduced from 33.1% to approximately 33.0%.

<sup>&</sup>lt;sup>1</sup> The valuation was commissioned by the Manager and the Trustee, in its capacity as trustee of Ascendas Reit, and was carried out by Knight Frank Pte Ltd using the capitalisation approach and discounted cash flow analysis.

The transaction is expected to complete within the first quarter of 2018, following which Ascendas Reit will own 100 properties in Singapore and 31 properties in Australia. The proposed sale has been approved by JTC Corporation.

In accordance with Ascendas Reit's Trust Deed, the Manager is entitled to a divestment fee of 0.5% of the sale price of the Property, which would be paid in cash.

## **About the Property**

No. 84 Genting Lane is located in the established industrial estate bounded by MacPherson Road, Jalan Kolam Ayer and Aljunied Road. The building is designed with regular and efficient floor plate. It has a gross floor area of 11,917 sq m and occupancy of 90.1% as at 30 September 2017. At approximately 19 years old, the Property still has remaining land lease tenure of about 22 years.
